**1.0 PURPOSE**

In accordance with Board Policy 3.14 Student Drug and Alcohol, the purpose of this procedure is to establish guiding principles and operational direction in the administration of a student drug and alcohol issues.

**4.0 DEFINITIONS**


A. *Controlled Substance* – Means a controlled substance in Schedules I through V of Section 202 of the Controlled Substances Act (21 U.S.C. 812), and as further defined by regulations at 21 CFR 1300.11 through 1300.15; or Wyo. Stat. Ann. §§ 35-7-1014-1022 (2009); and all other applicable federal, state, or local law.

**5.0 PROCEDURES**

- A. Controlled Substances and alcoholic beverages are not allowed on campus or at college-sponsored activities. Alcohol may be used for instructional (non-consumption) purposes with the approval of the instructor and the appropriate division dean.
- B. The college will take disciplinary action for the following controlled substance and alcohol policy violations which occur on campus or off campus at college sponsored activities.  
 (See Procedure 3.17P Student Code of Conduct.)
  - 1) The manufacture, possession, use, sale, or distribution of narcotics, illegal drugs, drug paraphernalia or prescription drugs for which the person does not have a prescription, including being under the influence.
  - 2) The manufacture, possession, consumption, sale, or distribution of alcoholic beverages including public intoxication.
- C. The Drug-Free School and Communities Act Amendments of 1989 (Public Law 101-226) requires that Laramie County Community College inform students and employees of the legal sanctions of illicit drugs and alcohol. This information is made available to all campus community members on the LCCC Campus Living and Learning website.
  - 1) Students are responsible for complying with provisions of Wyoming law that make it a crime to possess, sell, deliver or manufacture those drugs designated collectively as controlled

substances (including but not limited to Wyoming Statutes 12-6-101, 35-7-1031, 35-7-1037, 35-7-1014 thru 1022, and 31-5-233 thru 235).

- 2) Any student who violates the law will be subject to prosecution and punishment by the criminal and civil authorities and to disciplinary proceedings by the college.
