A RESOLUTION AMONG THE LEADERSHIP ORGANIZATIONS OF CHEYENNE AND LARAMIE COUNTY, WYOMING TO ENGAGE IN COMPREHENSIVE COMMUNITY VISIONING AND PLANNING.

THIS RESOLUTION, upon signature of all parties, is made effective on this ___ day of _____, 2017, between the primary leadership organizations of Cheyenne and Laramie County, and created by said parties through mutual consent and belief.

RECITALS

WHEREAS, Laramie County and the Greater Cheyenne Area is one of Wyoming's strongest communities, yet could be even stronger; and

WHEREAS, to become a stronger community, leadership across the community must plan and act collaboratively; and

WHEREAS, to plan and act collaboratively requires a purposeful commitment to an evidenced-based, rigorous assessment of the community, and a disciplined approach to strategic action; and

WHEREAS, to realize progress and growth in our community it will take the collective effort of each entity, committed to shared goals and for a common purpose.

NOW, THEREFORE, in consideration of the mutual covenants and commitments contained herein, the Parties agree as follows:

1. To commit to engage in an honest, evidenced-based and collaborative community visioning and planning process;
2. To appoint one person and one delegate to represent their respective organization, ensuring attendance at all required activities associated with the planning process;
3. To pay a sum total amount of five thousand dollars (\$5,000) to the Cheyenne Community Foundation to assist with the expenses associated with the planning process;
4. To the fullest extent allowable or possible, commit to the shared priorities, goals, and actions identified as part of the planning process; and
5. To the fullest extent allowable or possible, integrate into and execute the relevant actions and/or strategies identified in the planning process their respective organization.
