Overview

Environmental scanning is a process that systematically collects and assesses relevant information to understand the environment in which the College currently exists and perhaps expects to exist in the future. The institution gathers information about the external world, as well as itself internally to inform this process. The College then responds to the analysis of this information by crafting its strategies and plans accordingly. Thus, environmental scanning is one of the most essential, first-steps in the strategic planning process.

Therefore, the following is a suggested approach to conducting both an external and internal scan of the environment the College currently exists in.
