Current Position: Mayor, Novyi Buh City Council

Job Description: Management of work of local government, and creating proper conditions for the

life and development of the community.

Essay: My responsibility in my work is to create favorable conditions for the development of city territorial community. I have worked in the city council as a secretary for two terms, where I organized the work of the deputy corps, prepared and conducted plenary sessions of the council and its executive committee.
