

**Agreement between Laramie County Community College (LCCC) and
American Public University System (APUS)
for the Articulation of the Associate of Science Degree in Homeland Security to the
Bachelor of Arts in Homeland Security**

Purpose

This agreement facilitates the transfer of **Laramie County Community College (LCCC)** students who graduate with an Associate of Science (A.S.) degree in Homeland Security (HS) to the Bachelor of Arts in Homeland Security (HS) at American Public University System. This agreement defines the terms of the transfer.

The three goals inherent in the agreement are to:

1. facilitate students' transfer from HS program at LCCC to the HS program at APUS as efficiently as possible.
2. establish a clear set of understandings and expectations for both institutions and programs.
3. establish a pathway for LCCC's HS graduates to earn a bachelor's degree education in Homeland Security as a means to advance their careers in the Homeland Security profession.

Articulation Agreement

Laramie County Community College (LCCC) and American Public University System (APUS) agree to offer articulated programs leading to the award of an A.S. in Homeland Security (HS) and a Bachelor of Arts in Homeland Security (HS). They further agree that students from LCCC, under this articulation agreement, may transfer credits earned for the HS degree at LCCC toward the HS degree at APUS. The agreement, also, is a publication of a clear set of understandings and expectations for both institutions and programs. Making expectations clear to students and between institutions not only contributes to the first goal, but also allows the institutions to work collaboratively to meet the needs of LCCC students and graduates. Like any policy agreement, this articulation agreement will need to be updated, revised and refined as the instructional programs are revised. The following general principles guide the implementation of this agreement:

1. This program is designed for students and graduates of the A.S. degree in HS at LCCC to transfer specific courses in which they have earned the grade of C (2.0 on a 4.0 scale) or higher. The number of credits transferred may not exceed 91 credit hours. The credit hours transferred from LCCC contribute to the fulfillment of the 121 credit hours required for baccalaureate completion.
 2. The Degree Completion Plan included with this document specifies courses that will transfer from LCCC to APUS.
 3. In order for the specified courses to transfer, students must earn a grade of C (2.0 on a 4.0 scale) or better in each course they want to transfer.

4. The maximum number of credits that will be accepted by APUS toward degree requirements from non-direct classroom instruction (including CLEP, AP, and other nationally recognized standardized examination scores) is based on annually published national scores with recommended credits. Credit awarded for PLA is not recognized by APUS without verification through the APUS PLA process.
5. For a smooth transition, students at LCCC may start taking courses in the Homeland Security program at APUS while they are completing the A.S. degree at LCCC.
6. LCCC students who complete the A.S. in HS will be given consideration for financial assistance at APUS.
7. LCCC and APUS agree to monitor the performance of this agreement and to revise it as necessary.
8. LCCC and APUS agree to publicize this program.
9. The parties shall review the Articulation Agreement and Degree Completion Plan at least one per year to determine any necessary changes. Upon mutual agreement of the parties, the Degree Completion Plan shall be modified to reflect these changes. Revision of the Degree Completion Plan itself will not affect the signed agreement.
10. APUS shall have the right to review the content and curriculum of the A.S. degree in Homeland Security at LCCC to ensure that they comply with APUS academic standards.
11. LCCC students will be admitted, enrolled and graduated in APUS in accordance with APUS's then-current requirements and policies and, as students of APUS, will be subject to the usual financial obligations and fees of APUS, as determined by APUS.
12. Each party acknowledges and agrees that it is subject to and shall comply with the requirements of the Family Educational Rights and Privacy Act, 20 USC 1232g, and its implementing regulations, 34 CFR pt. 99, as each may be amended from time to time.
13. LCCC shall not make any false, erroneous or misleading statements, representations, warranties or guarantees to its students, employees or other third parties with respect to APUS or APUS's services or programs.
14. LCCC shall not pay any of its employees or agents engaged in any APUS student recruitment or admissions activities or in any decisions regarding awarding student financial assistance to any APUS student, any bonus, commission, or other incentive payment that is based in any part, directly or indirectly, on success

in securing enrollments or the award of financial aid where such payment would be a violation of the requirements of 20 U.S.C. § 1094(a)(20) or 34 C.F.R. § 668.14(b)(22) or any other law or accreditation requirements, regardless of whether those requirements apply directly to LCCC.

15. The agreement may be terminated by either party after 60 days advance written notice to the other. Termination of the agreement will not affect any students currently enrolled in the Homeland Security A.S. program at LCCC who are taking courses at APUS or who have been accepted into the Homeland Security program at APUS.
16. This agreement becomes effective on the date that the last authorizing party has signed the agreement. The last signer will write the date on the signature page.

17. **General Provisions**

Applicable Law and Venue. The parties mutually understand and agree the construction, interpretation, and enforcement of this Agreement shall be governed by the laws of the State of Wyoming. In the event a dispute arises between the parties from or concerning this Agreement or the subject matter hereof, any suit or proceeding at law or inequity shall be brought in Laramie County Wyoming. The foregoing provisions of this paragraph are agreed by the parties to be a material inducement to both parties in executing this Agreement. This provision is not intended nor shall it be construed to waive LCCC's sovereign immunity as provided in WYO. STAT. ANN. § 1-39-101 (2013) *et seq.*, and all other applicable laws.

Indemnification. To the fullest extent permitted by law, each party to this Agreement shall assume the risk of any liability arising from its own conduct. Neither party agrees to insure, defend nor indemnify the other from any and all lawsuits, losses, liability for injuries, damages, claims, penalties, actions, demands or attorney fees arising from or in connection with the respective services performed under this Agreement.


Governmental/Sovereign Immunity. LCCC does not waive its Governmental and Sovereign Immunity by entering into this Agreement and specifically retains all immunities and defenses available to it as a governmental entity pursuant to WYO. STAT. ANN. § 1-39-101 (2013) *et seq.*, and all other applicable laws. LCCC fully retains all immunities and defenses provided by law with regard to any action, whether in tort, contract or any other theory of law, based on this Agreement. Designations of venue, choice of law, enforcement actions, and similar provisions should not be construed as a waiver of sovereign immunity. The parties agree that any ambiguity in this Agreement shall not be strictly construed, either against or for either party, except that any ambiguity as to sovereign immunity shall be construed in favor of sovereign immunity.

Confidentiality. Records shall not be disclosed or used for any purpose, except when permitted by the Family Educational Rights and Privacy Act (FERPA) (20 U.S.C. § 1232g; 34 CFR Part 99), and all other applicable Federal and State statutes and regulations and when such disclosure or use is required by law. To the fullest extent permitted by law, each Party agrees to indemnify and hold harmless the other Party, its elected and appointed officials, employees, officers, agents, successors, assignees and volunteers from any and all lawsuits, losses, liability for injuries, damages, claims, penalties, actions, demands or expenses arising from or in connection with any violation of this provision.


