

International Student Application Requirements

Provide Official transcripts from each secondary/high school and college attended. These must be translated into English. For international college transcripts, students must submit transcript evaluations through a National Association of Credential Evaluation Services (NACES) member organization
Submit official scores from TOEFL or IELTS. The minimum TOEFL score accepted at LCCC is iBt 61, IELTS 6.0, 500 (paper-based) or 173 (computer-based). Residents of UK, Ireland, Australia, New Zealand, and English-Speaking Canada are exempt.
Complete the Confidential Financial Statement in this application, and provide an original bank letter showing cash availability and/or letter of sponsorship. No photocopies of financial verification documents will be accepted. The form must be completed with the student's and sponsor's signature.
Complete the International Student Health Statement.
Attach copy of Passport ID page. Students transferring within the U.S. must also submit a copy of their visa and I-94 card.
If you intend to live on campus, submit the <u>housing application</u> . The Residence Halls fill quickly, so apply early.
