C. Election Update – Erin Taylor, Executive Director, Wyoming Association of Community College Trustees (WACCT)

The Wyoming Association of Community College Trustees (WACCT) is comprised of two Trustees from each of the eight community colleges. Trustee Erickson and Board Chairman Bob Salazar have served on the WACCT Board for a number of years. They are a C6 organization so they advocate for community colleges and they work very closely with the Wyoming Community College Commission (WCCC). WCCC coordinates and allocates funding and puts forth the budget in front of the appropriators and legislature.

Mrs. Taylor gave a brief election update, highlights of the election below.

- Wyoming become an even more conservative in the Wyoming legislative space. Wyoming is now the most conservative legislature in the country.
- With the redistrict, the Senate gained one seat and the House gained two seats.
- There are three brand new Senators and republicans move from 28 to 29, with two democrats.
- All committees have been released and are public.
- With the redistrict, the House gained two new seats with one in Laramie County and one in Natrona County.
- There are 26 new members of the House. Republicans moved from 51 to 57. Democrats dropped from 7 to 5 in the House.
- No third party in the House.

WACCT holds a webinar in January that walks through election updates, college by college, who is new, etc.

Mrs. Taylor walked through the WACCT Advocacy Platform handout.
